



## ANNEX 4-A

### PRODUCT SPECIFIC RULES

Based on the Harmonized System as amended on 1 January 2017

#### GENERAL NOTES

For the purposes of the product specific rules set out in this Annex:

- (a) the following definitions apply:

**chapter** means a chapter of the Harmonized System;

**heading** means the first four digits in the tariff classification number under the Harmonized System; and

**subheading** means the first six digits in the tariff classification number under the Harmonized System;

- (b) the product specific rule, or specific set of rules, that applies to a particular chapter, heading or subheading is set out immediately adjacent to the chapter, heading or subheading;
- (c) where the specific set of rules provides for more than one rule to be selectively applied, the order of the description of the rules does not indicate priority of application; and
- (d) notwithstanding the applicable product specific rules of origin, a good of chapters 28 through 38 that is the product of a chemical reaction, is an originating good if that chemical reaction occurred in the territory of one or more of the Parties. For the purposes of this rule, a chemical reaction is a process (including a biochemical process) which results in a molecule with a new structure by breaking intramolecular bonds and by forming new intramolecular bonds, or by altering the spatial arrangement of atoms in a molecule. The following are not chemical reactions:
- (i) the dissolution in water or other solvents;
  - (ii) the elimination of solvents, including solvent water; or
  - (iii) the addition or elimination of water of crystallization.

#### **Chapter 61: Articles of Apparel and Clothing Accessories, Knitted or Crocheted**
